RE: Request for New Docket

Staff requests that a new docket be opened to address the 2013 annual recertification of Eligible Telecommunications Carriers (ETCs). Commission Order No. 06-292 in Docket No. UM 1217 requires all ETCs to file reports by July 15 of each year in order to continue receiving federal universal service support. Due to the large number of ETCs that file reports, each year a new docket is opened to handle and track the required reports.

Staff requests the opening of a new docket for the 2013 reports and the annual recertification process for this year. While ETC requirements are currently under review in Docket No. UM 1648, activity in that docket will not negate the need for the filing of reports by ETCs this year, as well as a Commission Order recertifying Oregon ETCs to the FCC by October 1. Therefore, a new separate docket for reporting is still needed.

The new UM docket should be captioned as follows: 2013 Annual Recertification of Eligible Telecommunications Carriers.
