Pursuant to ORS 759.410, Malheur Bell is filing notification of revisions to the sheets listed on Attachment A.

This filing fills gaps in Oregon Public Utility Commission archives for Pages 9 and 14 of Section 1 of Qwest's Malheur Exchange and Network Services Catalog, 2nd Edition. These deficiencies were identified by Kathy Williams of the PUC Staff, who advised Qwest that the transmittal containing these pages was not received by the Commission, which our records show as having been filed under Transmittal No. 2002-01-C. Ms. Williams also informed us that Transmittal No. 1999-05-C was withdrawn, therefore making it necessary to file Pages 9 and 14 with this correcting transmittal as Release 5 and Release 12, respectively. Ms. Williams further requested that Qwest use on this transmittal the effective date of Transmittal 2002-01-C, which was January 14, 2002.
