INTERCONNECTION, COLLOCATION AND RESALE AGREEMENT

FOR THE STATE OF OREGON

360networks (USA) inc.

and

United Telephone Company of the Northwest d/b/a CenturyLink

This Interconnection, Collocation and Resale Agreement ("Agreement"), dated August 10. 2010, is entered into by between 360networks (USA) inc. ("CLEC") an Oregon CLEC, and United Telephone Company of the Northwest d/b/a CenturyLink ("CenturyLink"), an Oregon corporation, to establish the rates, terms and conditions for local interconnection, collocation, and the purchase of unbundled network elements for the state of Oregon. CenturyLink and CLEC may be referred to individually as a "Party" and together as the "Parties."

NOW THEREFORE, the Parties agree as follows:

1. CONDITIONS

The Parties agree that the Agreement between the Parties shall consist of the Interconnection, Collocation and Resale Agreement for the State of Oregon entered into by and between CenturyLink and Axxis Communication Inc., dated May 7, 2010 ("Adopted Agreement").

All services provided under this Agreement will be consistent with the decisions of courts having jurisdiction over this Agreement, including but not limited to the decisions of the Court of Appeals and the United States Supreme Court.

2. PARTIES:

CLEC is hereby substituted in the Adopted Agreement for Axxis Communication Inc. CenturyLink shall remain as the other Party to the Adopted Agreement. Except as modified herein, the Agreement shall in all other respects reflect the same terms as the Adopted Agreement.

3. TERM:

The End Date of this Agreement is May 7, 2012, which corresponds with the End Date of the Adopted Agreement.

4. **NOTICES**:

Except as otherwise provided, all notices and other communication hereunder shall be deemed to have been duly given when made in writing and delivered in person or deposited in the United States mail, certified mail, postage paid, return receipt requested and addressed as follows:
