**Subject:** Re: OPUC Docket PCN 5 -- Notice of Response to Filing of Idaho Power

Judge Mellgren:

This response is per the approval of Greg Larkin to respond to the attached letter from Idaho Power in the following manner:

The letter provided by Idaho Power supports the validity of concern regarding the distribution of medical information being requested by them. The medical information is not relevant to the decision of the PUC regarding whether or not Idaho Power has performed due diligence in obtaining medical information regarding the safety and health impacts to **all those exposed** to excess noise. Idaho Power is now requiring information from me that has not been demanded of anyone else who will be exposed to noise limits beyond state safety limits simply because I am pursuing this issue as needed to protect the public interest. I submit that the information provided today is more than can legitimately be requested of me in response to Discovery Requests One and Two. Any additional information requested represents information that will provide no information relevant to the PUC decision process, is excessively burdensome, costly and serves only to intimidate and attempt to dissuade me from continuing with the issue.

Please see that any further demands for medical information be provided to you as a motion requesting an order and decision regarding whether the additional information is necessary for the Public Utility Commission to determine if Idaho Power has identified the medical issues of all citizens exposed to noise exceedances and provided appropriate mitigation to address the exceedances at the locations where they are occurring. I request that any order require Idaho Power provide financing for and a means to provide information being requested in the format required and/or pay for copying and mailing of the information due to the significant time and financial burden such a request places on me and those I rely upon to respond to such a request.
