As of May 27, 2018, Mel and Connie Kroker ("Krokers") have installed a fully operational well and water delivery system on their property. On behalf of the Krokers, pursuant to OAR 860-036-1560, I am requesting that within seven days, the Mountain Home Water District (the "Company") disconnect its water system on the downstream side of the Company's existing water meter from where it connects to the Krokers' water line.

Based on documents of public record describing the Company's water system and introduced by the Krokers in case UM1769, the Company's water meter is located near the southern boundary of the 50 foot wide utility easement which is referenced on Sheets 2 and 3 of Partition Plat No. 2013-015 filed by Keith Ironside (see Intervenors/403). The Company's water meter is connected to the northern end of the Krokers' water line. The Krokers' water line lies within the five-foot wide water line easement recorded under Document No. 74-6127. The specific location of the Krokers' water line easement is shown on Pages 1 and 2 of Partition Plat No. 2000-117 (see Intervenors/405).

Once the Company has disconnected its water meter and water system from the Krokers' water line, please provide written confirmation that such disconnection has been completed and that the Company's facilities have been properly capped as necessary to prevent any continuing discharge of water. Written confirmation is necessary given the significance of the Krokers' requested disconnection per the terms and conditions of the parties' amended stipulation filed of record in OPUC Case No. UW 172.
