IDAHO POWER COMPANY'S CROSS  
EXAMINATION STATEMENT

1           In accordance with Administrative Law Judge (“ALJ”) John Mellgren’s March 10, 2023  
2 Ruling, Idaho Power Company (“Idaho Power”) submits its Cross-Examination Statement to the  
3 Public Utility Commission of Oregon. Idaho Power does not intend to cross-examine any  
4 witnesses at the April 19-20, 2023, Cross Examination Hearing. However, Idaho Power reserves  
5 the right to conduct follow-up questioning or examination of any witnesses that are cross-  
6 examined by other parties or questioned by the ALJ, or the Commissioners.

7           Based on Chief ALJ Moser’s comments at the March 21, 2023 workshop, Idaho Power  
8 understands that on Friday, April 14, 2023, the ALJ will issue a scheduling memorandum for the  
9 Cross-Examination Hearing detailing the witness order and time estimates for each witness. To  
10 ensure that all necessary Idaho Power witnesses are available, Idaho Power respectfully  
11 requests that the ALJ also identify in the scheduling memorandum whether there are any  
12 additional Idaho Power witnesses that have not been called for cross-examination by parties to  
13 the proceeding but for whom Commissioners or the ALJ may have questions, and confirm that  
14 witnesses not identified in the scheduling memorandum may be excused from attending the  
15 Cross-Examination Hearing.
