Pursuant to Administrative Law Judge Hardie’s October 21, 2009 Ruling, the Industrial Customers of Northwest Utilities (“ICNU”) submits the following Cross Examination Statement. ICNU does not currently intend to cross examine any witnesses in this proceeding. PacifiCorp and the stipulation parties, however, have not yet filed their Reply Testimony in Support of the Stipulation. ICNU may conduct discovery about the Reply Testimony, and after review of the Reply Testimony and discovery responses, ICNU may submit an amended cross examination statement. ICNU will inform the ALJ and the parties by the close of business on Friday October 30, 2009 whether it will submit an amended cross exam statement. ICNU also reserves the right to ask questions of any witnesses which are examined by the ALJ or Commissioners.
