This is a summary of the facilities inspection for Cal-Ore Communications, Inc. (Cal-Ore) for the calendar years 2008 through 2012. (Please note that the original authority to conduct CLEC business in Oregon was in the name of Cal-Ore Telephone Co. but that authority was later transferred to Cal-Ore Communications, Inc.) Cal-Ore provides fiber to the premise and fixed wireless CLEC service in the Klamath Falls, Oregon area. Cal-Ore does not own poles but does have fiber attachments on poles owned by other companies. As of the end of 2012, the majority of Cal-Ore cable was buried and less than five years old. Fiber cable and associated equipment is monitored electronically for integrity and quality of service. This is a 24X7 continuous process. Additionally, above ground plant facility is visually inspected on a regular basis.
