The Industrial Customers of Northwest Utilities (“ICNU”) files this Notice of Intent to Request an Issue Fund Grant in Docket Nos. UE 177, UE 178, UG 170, and UG 171, pursuant to OAR § 860-017-0050 and the Intervenor Funding Agreement (“IFA”) approved by the Oregon Public Utility Commission (the “Commission”) in Order No. 03-388 (July 2, 2003).

1. In November 2005, the Commission opened several investigations into establishing an automatic adjustment clause pursuant to Senate Bill 408 (the “Proceedings”). The Proceedings were docketed as UE 177, UE 178, UG 170, and UG 171. ICNU has fully participated in the Proceedings.

2. On April 11, 2007, the Commission issued its findings in the Proceedings regarding the automatic adjustment clause, thereby closing the initial phase of the Proceedings.

3. On October 15, 2007, PacifiCorp and Portland General Electric Company (“PGE”) filed their tax reports for 2006. On October 25, 2007, the Commission scheduled a Prehearing Conference for Nov. 5, 2007, to establish a procedural schedule for the review of the tax reports. The review will be conducted within the established Proceedings.

4. Section 6.2 of the IFA requires that a Notice of Intent be filed at the time ICNU is requesting intervention in the proceeding. However, the review of the filed tax reports represents new proceedings under previously-established docket numbers. Thus, ICNU does not need to file a renewed intervention. ICNU is filing this Notice at the time of the Prehearing Conference for the Proceedings, and thus, timely for parties who would petition to intervene in the Proceedings.

5. The Proceedings are Eligible Proceedings under the IFA. The IFA defines an Eligible Proceeding as “any Commission proceeding that directly affects one or more of the Participating Public Utilities.” IFA, Section 1(c). UE 177 and UE 178 will directly affect PacifiCorp and PGE, which are Participating Public Utilities under Section 1(k) of the IFA. Therefore, an Issue Fund Grant may be made for this proceeding under Section 6.1 the IFA.

6. As required by IFA Section 6.2, this Notice of Intent is being served on each affected Participating Public Utility, all precertified organizations, and all parties identified on the service list from the Proceedings.

7. ICNU identifies the PacifiCorp and PGE Issue Fund Accounts as the accounts from which ICNU intends to request the Issue Fund Grant.

8. ICNU has been precertified under Sections 5.1 and 5.2 of the IFA and OAR § 860-017-0050(3), as eligible to receive an Issue Fund Grant, by Commission Order No. 03-502, which was entered on August 21, 2003.

9. ICNU requests that the Commission establish a deadline by which ICNU must file a proposed budget with respect to the Issue Fund Grant, as provided in Section 6.3 of the IFA.
