**RE: UE 178 – PGE’s Supplemental Response to Staff’s Initial Findings**

On January 15, PGE received a revised template from the OPUC Staff reflecting the impact of Staff’s remaining issues not previously incorporated in PGE’s revised template filed on January 2.
