In Order No. 08-543, the Commission adopted an all-party Stipulation in this docket. Under paragraph 17 of the Stipulation, PacifiCorp agreed to convene a series of workshop for the purpose of seeking consensus on the specific elements of future TAM proceedings. The Company also agreed that if parties could not reach consensus on the elements of TAM updates, revenue growth adjustments, and filing requirements in the workshops, the Company would initiate a Commission proceeding to resolve the issues. The Company agreed to initiate this proceeding by January 15, 2009.

On January 13, 2009, PacifiCorp filed a letter providing notice that all parties to the Stipulation agreed to a one-week extension of the January 15, 2009 filing deadline to January 22, 2009. The parties are continuing to work on these issues and have agreed to an additional two-week extension. The parties agree that February 5, 2009 is the new date by which the Company must file to initiate a proceeding, assuming the parties do not reach consensus on TAM design.


