

5. CUB identifies the 2012 PGE Issue Fund Account as the account from which CUB intends to request the Issue Fund Grant.
6. CUB has been precertified under Article 5.2(a) of the IFA and OAR 860-001-0120(3)(a), as eligible to receive an Issue Fund Grant.
7. CUB will file a proposed budget with respect to the Issue Fund Grant, as provided in Article 6.3 of the IFA.
