Citizens' Utility Board of Oregon (CUB) files this Notice of Intent to Request an Issue Fund Grant in UE 256, pursuant to OAR 860-001-0120 and the First Amended and Restated Intervenor Funding Agreement (IFA), approved by the Oregon Public Utility Commission (Commission) in Order No. 07-564 (December 19, 2007).<sup>1</sup>

1. Portland General Electric (PGE) has filed its 2011 Annual Power Cost Variance Mechanism. The Commission will examine this filing in Docket No. UE 256.
2. UE 256 is an Eligible Proceeding under the IFA. The IFA defines an Eligible Proceeding as "any Commission proceeding that directly affects one or more of the Participating Public Utilities." IFA, Article 1(c).

<sup>1</sup> CUB acknowledges that pursuant the IFA, it was to file its Notice of Intent to Request Issue Fund Grants contemporaneously with its Notice of Intervention. CUB filed its Notice of Intervention with the Commission on July 17, 2012. Because this docket is still in its early stages and the deadline for proposed Issue Fund Budgets has not passed, CUB does not feel that any interested party is unduly prejudiced by its untimely filing of this Notice of Intent to Request Issue Fund Grants.

3. UE 256 will directly affect PGE, which is a Participating Public Utility under Article 1(k) of the IFA.
4. As required by IFA Article 6.2, this Notice of Intent is being served on each affected Participating Public Utility, all precertified organizations, and all parties identified on the service list from UE 256.
5. CUB identifies the 2012 PGE Issue Fund Account as the account from which CUB intends to request the Issue Fund Grant.
6. CUB has been precertified under Article 5.2(a) of the IFA and OAR 860-001-0120(3)(a), as eligible to receive an Issue Fund Grant.
7. CUB will file a proposed budget with respect to the Issue Fund Grant, as provided in Article 6.3 of the IFA.
