8 On June 27, 2013, staff of the Public Utility Commission of Oregon (staff) filed a status  
9 report stating that the parties had entered a Stipulation resolving the issues in this docket and  
10 were working on finalizing it and the supporting testimony. Staff stated the Stipulation would be  
11 filed no later than July 5, 2013.
