**RE: UE 400—PacifiCorp's Jim Bridger Long-Term Fuel Plan**

In accordance with Order No.21-379, as amended by Order No. 22-065 issued February 28, 2022, PacifiCorp d/b/a Pacific Power hereby submits for filing its Jim Bridger Long-Term Fuel Plan (LTFP).

The Jim Bridger LTFP contains highly commercially sensitive, non-public information related to PacifiCorp's fueling strategy at the facility. As a result, PacifiCorp classifies the Jim Bridger LTFP as highly confidential in its entirety and provides it in accordance with Modified Protective Order No. 22-063.

In PacifiCorp's opening testimony, PacifiCorp noted that it anticipated providing an analysis that explores the cost and benefits of contract termination or renegotiation of the Huntington CSA by April 15, 2022.<sup>1</sup> PacifiCorp now provides an update that it expects to provide this analysis by the end of this month (April 2022).
