**SUBJECT:** UM 1129 Compliance Filing of Pacific Power pursuant to Order No. 06-538  
(Advice No. 06-019)

On October 20, 2006, Pacific Power filed Advice No. 06-019 with a requested effective date of November 19, 2006, pursuant to Order No. 06-538 (Docket UM 1129). At its public meeting on November 7, 2006, the Commission suspended the filing to provide staff sufficient review time.

During the investigation of the filing, staff found no inconsistencies with Order No. 06-538. The Oregon Department of Energy indicated that it found no issues with the filing.

I find the filing complies with Order No. 06-538. I recommend the Commission approve the filing and request the company issue tariff sheets and standard contracts with new effective dates. I further recommend the Commission direct the company to remove from the standard contracts Section 24, Commission Investigation, 30 calendar days from the effective date of the revised standard contracts and tariff sheets. This provision is pursuant to Order No. 05-899. A Commission order approving this filing concludes the investigation for Pacific Power.
