Pursuant to the Administrative Law Judge's Memorandum dated January 3, 2006, Idaho Power Company ("Idaho Power") submits the following cross-examination statement. Idaho Power wishes to cross-examine the following witnesses of the Oregon Public Utility Commission Staff ("Staff") and the Oregon Department of Energy ("ODOE") at the hearing currently scheduled for February 2, 2006. Idaho Power intends to cross-examine these witnesses generally regarding their Track 1 direct and rebuttal testimony. Based on Idaho Power's cross-examination time estimate, Idaho Power believes that one day will be sufficient for completion of the hearing in this Track 1.
