In a letter to you dated June 7, 2007, I indicated that the parties to this docket had agreed to continue to suspend further activity in this docket pending issuance of an order by the Federal Communications Commission ("FCC"), in WC Docket 05-337, addressing the Recommended Decision released May 1, 2007 by the Federal-State Joint Board on Universal Service ("Recommended Decision"). In that letter I also indicated that the parties would report back to you no later than August 22, 2007. The FCC has yet to act upon the Recommended Decision. 
