In letters to you dated June 7, 2007 and August 22, 2007, I indicated that the parties to this docket had agreed to continue to suspend further activity in this docket pending issuance of an order by the Federal Communications Commission ("FCC"), in WC Docket 05-337, addressing the Recommended Decision released May 1, 2007 by the Federal-State Joint Board on Universal Service ("Recommended Decision"). In the August 22, 2007 letter, I also indicated that the parties would report back to you no later than October 22, 2007. The FCC has yet to act upon the Recommended Decision. Accordingly, the parties have agreed to continue to suspend further activity in this docket pending action by the FCC. 
