Section of the Public Utility Commission of Oregon.

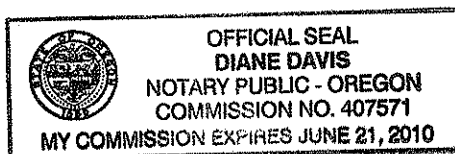
2. I, along with a number of other witnesses in this docket, filed testimony on

Company, McLeodUSA Telecommunications Services, Inc., and 360 Networks.





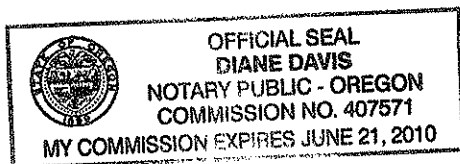
