Dear Judge Arlow:

On behalf of the Oregon Cable Telecommunications Association (OCTA), and in response to the request for information sent by Ms. Taylor on your behalf earlier today, I write to provide the following information with respect to the schedule in Docket UM 1481.

In connection with its recently-filed motions to compel, OCTA has conferred with the following parties in the case regarding scheduling: Frontier Communications Northwest, Inc., CenturyLink, Inc., Oregon Telecommunications Association (OTA), the Oregon Public Utility Commission Staff ("Staff"), Verizon, and the Citizens Utility Board of Oregon. Each of those parties has indicated that they agree to, or do not oppose, moving the current opening testimony date from November 26, 2012 to December 10, 2012.

CenturyLink, Frontier, OTA and Staff have also agreed to a schedule under which any responses to OCTA's motions to compel must be filed on Tuesday, November 20, 2012. OCTA agrees that its reply to those responses will be due on Wednesday, November 21, 2012. These proposed changes are intended to give Your Honor the opportunity to rule on the motions to compel as early as you see fit, well in advance of the proposed December 10, 2012 opening testimony date.

In addition, all the parties mentioned above indicated consent (or non-opposition) to moving the reply testimony date from January 16, 2013 to January 30, 2013, and requesting that the hearing scheduled for February 4, 2013 be moved approximately two weeks (*e.g.*, to February 18, 2013), subject to Your Honor's scheduling needs.
