Pursuant to Section 6.1 of the Second Amended and Restated Intervenor Funding Agreement,<sup>1</sup> the Oregon Citizens' Utility Board ("CUB") submits this request for payment of \$60,000 of eligible expenses from the PacifiCorp MSP Issue Fund.

On May 3, 2018, CUB submitted grant request with a proposed budget of \$40,000 from the 2018 PacifiCorp MSP Issue Fund. On May 8, 2018, in Order No. 18-150, the Commission approved CUB's grant request. On November 11, 2018, CUB submitted an amended grant request with an amended budget of \$60,000, which was approved by the Commission on December 10, 2018 via Order 18-461.

Under Section 6.1 of the Agreement, each Issue Fund Grand Request for Payment must:

- (a) Itemize the expenses, payees and hourly rates for amounts to be reimbursed;*
- (b) Demonstrate that the expenses are reasonable and are directly attributable to MSP Activities pursued on behalf of a particular customer class; and*
- (c) Provide information sufficient to show that the Participating Intervenor has complied with any condition or requirement of the MSP Fund Grant, including, but not limited to, documentation sufficient to show that the Participating Intervenor has satisfied the matching fund requirement (i) set forth in this Section or (ii) as the Commission may require as a reasonable condition on MSP Fund Grants, whichever applies.*

Confidential Attachment A contains a summary of CUB's expenses in this case. Confidential Attachment B provides a list of CUB activities by date and Intervenor Funding Task Category. Confidential Attachment C is an invoice to PacifiCorp,

including travel cost details.

- (b) The expenses incurred are reasonable and directly attributable to the issues and positions CUB addressed MSP negotiations on behalf of residential customers. In support of this assertion, we supply Confidential Attachments A, B and C, which can be compared to CUB's Issue Fund Budget in this case.
- (c) CUB has satisfied the matching fund requirement as demonstrated in Attachment A, the summary of CUB's expenses.
- (d) This is a request for partial payment.

CUB's expenses to date total \$73,067 but in this filing CUB limits the request of payment in UM 1586 to \$60,000. *See* Confidential Attachment A, CUB Expense Summary. The attached documents should allow the Commission to track the time spent on the elements of the case, and we believe that this filing meets the requirements of the Commission.
