Subject: Procedural schedule in Docket No. UM 1610

Dear ALJs Pines and Kirkpatrick:

The parties have had opportunity to discuss the procedural schedule in UM 1610. It does not appear that we can agree on a date in June because of conflicts. We ask that we proceed with a hearing on May 23, 2013. Given the short timeline, we ask that you allow us until May 20, 2013 to submit the pre-hearing briefs. The schedule we agreed to is as follows:

May 17 at noon: Parties file cross-examination statements.
May 20 (COB): Parties file pre-hearing briefs.
May 21 (COB): Parties file cross-exam exhibits.
May 23: Hearing.

Also, given the number of witnesses in the case, we ask that if possible, you schedule a second day for cross-examination during the week of May 27th (but not May 27), in the event that we do not complete cross-examination on May 23rd.
