Portland General Electric (PGE) submits this filing pursuant to Oregon Revised Statutes 757.205, 757.210, and 758.505 through 758.555; Oregon Administrative Rules 860-029-0001 through 860-029-0100; Order No. 11-505; and Order No. 14-058.

PGE originally submitted the filing on May 30, 2014. A Supplemental Filing was made on June 19, 2014 to correct the courtesy red lined versions of the Standard Power Purchase Agreements (PPA) that did not include all of the red lines for changes made in the compliance filing. PGE now makes this Supplemental Filing to extend the effective date of PPAs and Sheet Nos. 201-1 through Sheet Nos. 201-20 from July 15, 2014 to August 1, 2014. Parties and Staff have a workshop scheduled for July 23, 2014 to discuss PGE’s compliance filing. At this time, all PPAs and Sheet Nos. 201-1 through 201-20 remain as originally filed.


