



Program Administrator's Project Recommendation

Community Solar Program - Docket No. UM 1930

On October 30, 2024, in Order No. 24-364, the Commission permitted the delegation of Commission authority to the Community Solar Program Administrator (PA) to grant noncontroversial project pre-certifications, waivers, extensions, and amendments. Under the permitted delegation of authority, Staff will post the PA's project recommendation to UM 1930 with a comment period of two weeks. If no comments in opposition are received prior to the end of the comment period, the recommendation will go into effect. If comments in opposition are received prior to the end of the comment period, the recommendation will not go into effect and the matter will be referred to the Commission for a decision at the next available public meeting.

Staff posts the PA's recommendation to grant project pre-certification for the following project:

PGE-2025-200 (Vanport Community Solar)

The PA has reviewed the Project Manager (PM) pre-certification application for the project listed above and has recommended granting pre-certification. Staff finds the PA's recommendation to be noncontroversial and that granting pre-certification may be delegated to the PA.
