



# Distribution System Planning Docket Announcement

## Part 2 of Inaugural Plans Filed and Request for Public Comment

August 30, 2022

PGE, Pacific Power, and Idaho Power filed Part 2 of their inaugural Distribution System Plans (Plans) on August 15, 2022. Utilities filed Part 1 of their Plans on October 15, 2021. These filings were required by [Order No. 20-485](#), which established distribution system planning (DSP) guidelines.

This announcement provides information on where to access the filings, requests public comment, and summarizes the process to review Part 2 of the DSP Plans.

Links to each utility's Plan, and the respective dockets, are below. Review, public comment, and Commission action will be conducted in these dockets.

### Public Comment Requested

Oregon Public Utility Commission (PUC) Staff requests feedback on Part 2 filings. Stakeholders and interested parties may provide comments through the methods described below. **The deadline for public comment is Friday, October 7, 2022, 4 p.m. Pacific.** Staff will evaluate Part 2 of each utility Plan, and in so doing will review public comment received on each filing.

### Special Public Meeting

The PUC will hold a Special Public Meeting at which PGE, Pacific Power, and Idaho Power will present Part 2 of their Plans. **The Special Public Meeting will be held virtually on Thursday, September 15, 2022, from 8:30 a.m.-12:00 p.m. Pacific.** An agenda with additional detail and participation information will be posted closer to the event in Docket Nos. UM 2005, UM 2196, UM 2197, and UM 2198.

### Review of the Part 2 Filings

**A second Special Public Meeting will be held Tuesday, January 31, 2023, from 1:30 p.m.-4:30 p.m. Pacific.** At this meeting PUC Staff will provide recommendations to the Commission. The Commission will determine whether to accept Part 2 filings based on whether they meet the criteria and requirements of the DSP Guidelines.
