Clean Energy Plans include requirements surrounding community engagement. This workshop will review information provided by utilities and stakeholders regarding community engagement activities and identify opportunities for refinement of those plans, particularly based on stakeholder feedback

Specific goals include:

- *Surface reflections from the stakeholders involved in DSP and/or IRP—or another docket they have been a part of—to understand what utility engagement methods have worked well and where we should consider engaging differently to inform CEP engagement needs;*
- *Hear the key elements and updates on PAC and PGE utility engagement proposals, and identify further questions from utilities and stakeholders to address in updated plans;*
- *Share stakeholder perspectives on priorities for engagement in CEP, for further reflection and discussion;*
- *Prioritize outstanding engagement questions and work together to address them in breakout groups, for utilities to consider including in updated plans and staff to consider including in guidelines.*
