To Interested Parties:

Staff of the Public Utility Commission (Staff) previously filed a schedule for this docket on May 13, 2024. Following consultation with interested parties and the utility, Staff provides the following schedule update, amending the dates for the Staff Report, All Party Reply Comments, and Special Public Meeting (shown in blue). All other dates remain the same. Staff requests this schedule to be added to the docket:

The Commission approve issuance of Idaho Power Company's RFP in Order No. 24-272, and waived OAR 860-089-0350(1) to allow the RFP to proceed subject to the schedule specified in the final draft RFP. Staff is requesting the amendment of the approved schedule, which moves the public meeting for short list approval, as well as the related Staff memo and stakeholder comments, from March 4, 2025 to March 21, 2025. Staff also includes the schedule for Group 2 bids, as approved by the Commission in August. Staff coordinated with all stakeholders in this docket and received no objections to its amended schedule.
