**PACIFICORP’S MOTION TO ADMIT
FOURTH PARTIAL STIPULATION**

Concurrently with this Motion, PacifiCorp d/b/a Pacific Power (PacifiCorp or the Company) is filing a Fourth Partial Stipulation resolving the issues around the Accelerated Commitment Tariff as outlined in the Fourth Partial Stipulation. This Stipulation is joined by PacifiCorp, Staff of the Public Utility Commission of Oregon, the Oregon Citizens’ Utility Board, Walmart Inc., Vitesse, LLC, and the Northwest Intermountain Power Producers Coalition.
