



Expedited Consideration Requested

1 Pursuant to OAR 860-001-0420, PacifiCorp d/b/a Pacific Power (Company)
2 requests the Administrative Law Judge (ALJ) to amend the schedule in this docket as
3 follows:

7 Staff's Final Comments	October 6, 2011	October 13, 2011


8 The Company contacted all of the parties to this proceeding on September 6, 2011
9 to inquire as to their position on the proposed amendment to the schedule. Staff and the
10 Industrial Customers of Northwest Utilities stated that they do not oppose this motion.
11 As of the time of filing, the other parties had not provided the Company with their
12 positions on this motion.

13 The proposed schedule allows the Company one additional week to submit reply
14 comments and also extends the due date for Staff's final comments by one week. The
15 additional time will enable the Company to more fully respond to the parties' comments
16 related to pollution control investments and coal plant utilization case studies. The
17 Company is currently modeling coal plant utilization scenarios in support of a Certificate

1 of Public Convenience and Necessity (CPCN) application in Wyoming for proposed
2 clean air investments at the Naughton plant, which is expected to be filed by mid-
3 September 2011. While this modeling effort is being done in support of investments
4 specific to the Naughton facility, its scope includes clean air investments required for the
5 Company's broader coal fleet. The Company believes parties will benefit by receiving
6 reply comments that are informed and supported by the modeling being done for the
7 Naughton CPCN application.

8 Under OAR 860-001-0420(7), PacifiCorp requests expedited consideration of its
9 request to amend the schedule. PacifiCorp requests that the ALJ shorten the time for
10 responses to this motion in order to provide for a ruling on this motion by September 14,
11 2011, the current due date for the Company's reply comments.
