1 Pursuant to OAR 860-001-0420, the Citizens’ Utility Board of Oregon (“CUB”) hereby
2 requests that the Commission amend the procedural schedule in docket LC 57 as follows:

- 3 • Staff and Intervenor Final Comments due Friday, January 10, 2014
- 4 CUB’s request takes into account the holiday schedules of its staff as well as the schedules in
5 other pending dockets, which make filing Final Comments on January 7, 2014 extremely
6 difficult.

7 In accordance with the requirements of OAR 860-001-0420(3) and OAR 860-001-
8 0420(7), CUB has conferred with PacifiCorp, Commission Staff, Oregon Department of Energy
9 (“ODOE”), Renewable Northwest Project (“RNP”), Industrial Customers of Northwest Utility
10 (“ICNU”), Northwest Energy Coalition (“NWEC”), and Natural Resource Defense Council
11 (“NRDC”), none of which object to CUB’s Motion to extend the filing date for Staff and
12 Intervenor Final Comments through January 10, 2014. At the time this Motion was filed, CUB
13 had not received responses from PGE, Idaho Power and Sierra Club regarding their positions on
14 CUB’s Motion.

15 CUB requests expedited consideration of this motion.
