

PROCEDURAL SCHEDULE**


On November 7, 2013 PacifiCorp d/b/a Pacific Power (Company) filed a motion to amend and temporarily suspend the procedural schedule in this docket. The motion was granted by Administrative Law Judge (ALJ) Shani Pines on November 8, 2013. In its motion, the Company committed to filing a motion to adopt a modified procedural schedule with the Public Utility Commission of Oregon by November 26, 2013.
