**PORTLAND GENERAL ELECTRIC
COMPANY’S MOTION TO ADOPT
PROCEDURAL SCHEDULE**

Expedited Consideration Requested

In Order 17-386, the Public Utility Commission of Oregon (Commission) acknowledged all action items in Portland General Electric Company’s (PGE’s) 2016 Integrated Resource Plan (IRP) except for one action item related to PGE’s renewable resource procurement. The Commission agreed to allow PGE the opportunity to file a revised action plan regarding renewable resource procurement and present that to the Commission. Consistent with the Commission’s order, PGE filed an addendum to the 2016 IRP with a revised renewable action plan on November 9, 2017. In the addendum, PGE asks the Commission to acknowledge its revised renewable action item at the December 18, 2017 Public Meeting. This will allow PGE the opportunity to take advantage of the expiring Production Tax Credit (PTC) by issuing a request for proposals (RFP) in early 2018. In order to facilitate this timing, PGE requests that the Administrative Law Judge (ALJ) adopt the following procedural schedule:

(PGE waives its opportunity for additional comment but reserves the right to request a change to the schedule if it believes a reply from PGE will help clarify issues for the Commission) |

At the request of Commission Staff, PGE also proposes that discovery turn-around be accelerated to 7 days beginning November 10, 2017.

PGE shared the proposed schedule at an October 27, 2017 IRP workshop and sent an email to the LC 66 service list on November 8, 2017 asking parties to let PGE know if they had any objections to the schedule by close of business on November 9, 2017. Commission Staff, Oregon Department of Energy, Sierra Club, and Renewable Northwest responded stating that they had no objections with the proposed schedule. PGE is not aware of any objections or concerns of any other party. Accordingly, PGE respectfully requests that the Commission adopt the procedural schedule set forth above.
