**PACIFICORP’S MOTION TO MODIFY
THE PROCEDURAL SCHEDULE**

Expedited Consideration Requested

In accordance with OAR 860-001-0420, PacifiCorp d/b/a Pacific Power (PacifiCorp or the Company) respectfully requests that the Public Utility Commission of Oregon (Commission) modify the procedural schedule in the above-captioned docket on an expedited basis to reflect Commission Staff (Staff) and PacifiCorp’s agreement to allow more time for Staff to respond to PacifiCorp’s Data Requests Nos. 10-13, for PacifiCorp to have the opportunity to include the responses as stipulated exhibits, and to reflect PacifiCorp and Staff’s agreement to a mutual waiver of cross-examination.

On November 14, 2025, Administrative Law Judge (ALJ) John Mellgren issued a Ruling modifying the schedule and instructing PacifiCorp and Staff to file a Joint Issues List on November 20, 2025. The Ruling also retained the original deadline for the parties’ Cross-Examination Exhibit Lists, Witness Lists, and Cross Exhibits, which are due on November 24, 2025, and additionally instructed that parties file their Position Statements on the same day.

Since the ALJ’s Ruling, PacifiCorp and Staff have conferred and agreed to a mutual waiver of cross-examination and that Staff will agree to the admission of Staff’s responses to PacifiCorp’s outstanding data requests as stipulated exhibits if PacifiCorp moves to include Staff’s responses in the record. However, Staff requires an extension of time to prepare its responses to the data requests due to Staff’s witness being unavailable during the month of November. Therefore,

PacifiCorp respectfully requests that the Commission modify the procedural schedule for docket PCN 8 as follows to reflect this agreement and allow more time for Staff to respond to PacifiCorp’s outstanding data requests, and to provide PacifiCorp the opportunity to include these responses as stipulated exhibits.

PacifiCorp also respectfully requests that the ALJ provide parties direction regarding whether the hearing will be cancelled in light of the parties not seeking cross-examination, and similarly, whether the ALJ requires the filing of the Joint Issues List and Position Statements if the hearing were to be cancelled.

The parties propose to modify the schedule for the submission of stipulated exhibits to December 3, 2025, and to retain the remaining dates subject to the ALJ’s guidance regarding the hearing, Joint Issues List and Position Statements, as follows:
