**PACIFICORP’S MOTION TO
SUSPEND PROCEDURAL
SCHEDULE**

(Expedited Consideration Requested)

In accordance with OAR 860-001-0420, PacifiCorp d/b/a Pacific Power (PacifiCorp or Company) respectfully requests that the Public Utility Commission of Oregon (Commission) issue an order suspending the procedural schedule in this docket. PacifiCorp and Commission Staff convened a settlement conference on November 25, 2025, and are presently engaged in negotiations that are intended to result in an agreement in principle resolving all issues in this docket. Because Parties’ Motions to Admit Testimony and Exhibits and Affidavit(s) in Support are due December 4, 2025, PacifiCorp requests expedited treatment of this Motion in accordance with OAR 860-001-0420(6).

Parties will provide an update regarding their progress toward reaching a settlement by December 10, 2025. If Parties are unable to reach an agreement, PacifiCorp and Staff will work with Administrative Law Judge John Mellgren to schedule a conference to set a new procedural schedule for the remainder of the actions in this proceeding. PacifiCorp has conferred with Staff and Staff supports this Motion.
