**MOTION TO ADMIT STIPULATION
AND REQUEST FOR WAIVER**

1 In accordance with OAR 860-001-0350(7)(b), on behalf of PacifiCorp d/b/a Pacific Power
2 (PacifiCorp or the Company) and Public Utility Commission of Oregon Staff (Staff), PacifiCorp
3 moves to admit the Stipulation and the Attestation of Adam Lint included as Attachment A to the
4 Stipulation, into the record in this proceeding. The Stipulation reflects the agreements of Staff and
5 PacifiCorp (collectively, Stipulating Parties) in this docket and is being filed concurrently with
6 this Motion.

7 The Stipulating Parties seek to file the Stipulation as soon as possible to notify the
8 Commission that the Stipulating Parties have resolved the remaining disputed issue in this
9 proceeding. Accordingly, PacifiCorp, on behalf of the Stipulating Parties, requests a waiver of the
10 requirement in OAR 860-001-0350(7) that settlements between parties be accompanied by joint
11 testimony or a supporting brief at the time of filing. The Stipulating Parties plan to file a supporting
12 joint brief no later than December 18, 2025.

13 For the foregoing reasons, PacifiCorp, on behalf of the Stipulating Parties, respectfully
14 requests that the Administrative Law Judge issue a ruling admitting the Stipulation into the record
15 as evidence in this proceeding and granting a waiver of the requirement in OAR 860-001-0350(7)
16 to concurrently file a joint brief.
