Sempra Global (the “Participating Parties”). An agreement in principal resolving all direct access related issues has been reached. Accordingly, the Participating Parties support this motion.

It is anticipated that a stipulation and supporting brief or testimony will be filed with the Commission on or before August 15, 2006. PGE requests that the July 25, 2006, testimony filing date be postponed either without date or to after August 15, 2006. If further testimony or other proceedings are needed regarding direct access issues, we will notify the Commission and request an expedited scheduling conference. No other date in the existing schedule in this consolidated docket need by changed.¹
