
11 Staff requests that administrative law judge admit Staff Exhibits 2000 and 2001 into the



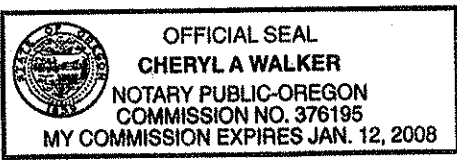


