**MOTION TO SHORTEN TIME TO

A Stipulation was filed in this docket on December 4, 2007, among Portland General Electric Company ("PGE"), Staff of the Public Utility Commission of Oregon ("Staff"), and the Citizens' Utility Board of Oregon ("CUB"). Pursuant to OAR 860-014-0085(5), PGE requests that the Commission shorten the time for other parties to file written objections to the stipulation or request a hearing.

OAR 860-014-0085(5) provides:

Within 20 days of the filing of the settlement or stipulation, any party may file written objections to the settlement or stipulation or request a hearing. Upon request or its own motion, the Commission or ALJ may set another time period for objections and request for hearing.

The tariffs in this docket were filed March 2, 2007, as Advice 07-07. In Order 07-114, the Commission suspended the tariffs for a period "not to exceed nine months from April 1, 2007." The suspension then ends on January 1, 2008. In order to hear and resolve any possible objections and issue a ruling prior to January 1, 2008, the time for filing the objections should be shortened. PGE requests that the time for filing written objections or a request for a hearing be shortened to 7 days from the date the Stipulation and Joint Explanatory Brief are filed.

There is only one party that has taken an active role in this docket that has not joined in the Stipulation – the Industrial Customers of Northwest Utilities ("ICNU"). Several weeks ago ICNU was provided a draft of the Stipulation that is not significantly different from the one filed.

**DOCKETED**

ICNU should not be prejudiced by a shorter time to file objections.

Staff and CUB support this motion.

For the reasons set forth above, PGE requests that the time for filing written objections or requesting a hearing with respect to the December 4 Stipulation be shortened to 7 days.




