I, Gordon Feighner, being duly sworn on oath, depose and say:

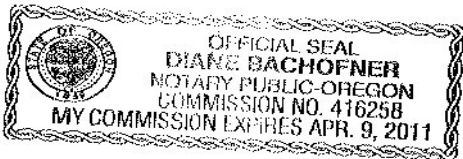
