MOTION TO SUSPEND SCHEDULE


7 Staff of the Public Utility Commission of Oregon (“staff”) asks the administrative law
8 judge to suspend the procedural schedule in this docket pending the filing of a stipulation
9 between all parties resolving all issues in this docket. The parties to this docket have reached a
10 settlement in principle and are working on final edits to the stipulation and brief in support of the
11 stipulation. Staff anticipates that the stipulation and supporting brief will be filed in the next few
12 business days, and no later than two weeks from today.

13 Counsel for staff contacted counsel for Portland General Electric Company and the
14 Citizens’ Utility Board of Oregon regarding this motion and neither objected. Counsel for Staff
15 attempted to reach counsel for the fourth party to the docket, the Industrial Customers of
16 Northwest Utilities, regarding this request, but he was unavailable.
