Settlement discussions in this docket, regarding PGE's 2010 annual power cost variance mechanism, were held September 21, 2011. All parties to this docket participated: Portland General Electric ("PGE"), Staff, the Citizens' Utility Board, and the Industrial Customers of Northwest Utilities. All parties reached a settlement in principal of all issues in this docket. The parties are drafting a Stipulation to be filed with the Commission, and anticipate that it will be filed within the next two weeks.
