
1. My name is Scott Wright and I am employed by Idaho Power Company as a Regulatory Analyst II in the Regulatory Affairs Department.

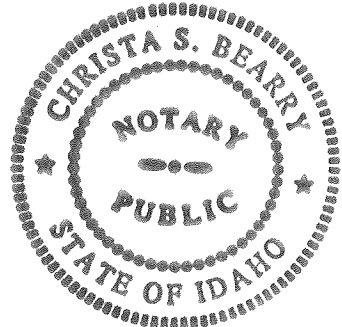
