

15 Power Company in this matter. (See Idaho Power/100-106 and 200-203).

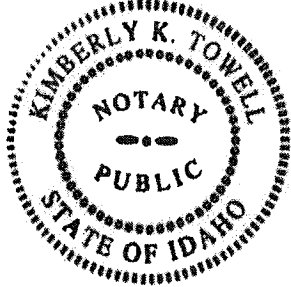
