I, BOB JENKS, being first duly sworn on oath, depose and say:

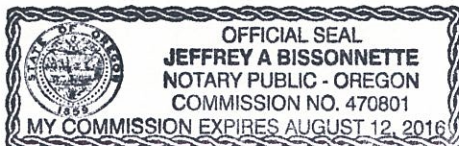
1. My name is Bob Jenks. I am Executive Director of the Citizens' Utility Board of Oregon ("CUB").

3. To the best of my knowledge, my pre-filed testimony is true and accurate. If I were asked the same questions today, my answers would be the same.


