



PROCEDURAL SCHEDULE
(Expedited Consideration Requested)

In accordance with OAR 860-001-0420, PacifiCorp d/b/a Pacific Power (PacifiCorp) respectfully requests that the Public Utility Commission of Oregon (Commission) issue an order amending the procedural schedule in this docket to extend the deadline for filing a settlement and supporting testimony from September 13, 2019 to September 23, 2019, in order to finalize all the technical aspects of the settlement.
