



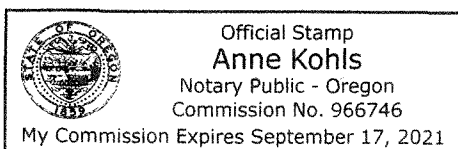
- 3 1. My name is Michael G. Wilding. I am employed by PacifiCorp d/b/a Pacific
