

MODIFY PROCEDURAL SCHEDULE**


*Expedited Consideration Requested*

Pursuant to OAR 860-001-0420, PacifiCorp d/b/a Pacific Power (PacifiCorp) respectfully requests that the Public Utility Commission of Oregon issue an order amending the procedural schedule in the above-captioned docket, as reflected in the table below.

Under the revised schedule, the parties’ pre-trial filings would be made one week in advance of the date of the hearing, September 9, 2020. In light of the number of issues that remain contested, and the short time period between PacifiCorp’s surrebuttal testimony and prehearing briefs, cross-examination statements, and cross-examination exhibits, additional time is necessary to in order to draft, review and finalize these documents. PacifiCorp has conferred with the other parties in this proceeding and is authorized to represent that the Staff of the Public Utilities Commission, the Citizens’ Utility Board, Alliance of Western Energy Consumers, Sierra Club, Walmart, Inc., Tesla, Inc., Small Business Utility Advocates, Calpine Energy Solutions, LLC, Klamath Water Users Association, the Oregon Farm Bureau Federation, Vitesse, LLC, and ChargePoint, Inc. support this motion.
