Pursuant to OAR 860-001-0420, Portland General Electric Company ("PGE"), on behalf of the parties in this docket, hereby moves the Administrative Law Judge for an order suspending the remainder of the procedural schedule in this docket.

The parties to this docket, PGE, Staff of the Public Utility Commission of Oregon (Staff), the Citizens' Utility Board of Oregon (CUB), and the Alliance of Western Energy Consumers (AWEC) held settlement discussions on September 10, 2021.
