MOTION TO SUSPEND PROCEDURAL  
SCHEDULE

**Expedited Consideration Requested**

1           In accordance with OAR 860-001-0420, Idaho Power Company Idaho Power Company  
2 (“Idaho Power” or “Company”) submits this Motion to Suspend Procedural Schedule. All parties  
3 to this case (Idaho Power, Staff, and the Oregon Citizens’ Utility Board (“CUB”)), have reached  
4 a settlement in principle that resolves all issues in this case. The parties request a suspension  
5 of the current procedural schedule to allow time to finalize and execute a settlement stipulation  
6 and supporting briefing.

7           Staff and intervenor testimony is currently due Thursday, April 11, 2024. Therefore, in  
8 accordance with OAR 860-001-0420(6), Idaho Power requests expedited consideration of this  
9 Motion. Idaho Power has conferred with Staff and CUB and both parties support this Motion  
10 and the request for expedited consideration.

1           The parties anticipate filing the settlement stipulation and joint brief in support of the  
2 stipulation by May 6, 2024, in accordance with the procedural schedule, and therefore still  
3 request a final order by May 31, 2024.
